

**BY-LAW 202**

**A BY-LAW RELATING TO THE CORPORATE SEAL**

---

**BE IT ENACTED** by the Mayor and the Councillors of the Town of Oromocto as follows:

1. The Corporate Seal of the Town of Oromocto shall be what is known as a stamp seal, circular in form, so made as to make an impression of two circles, one within the other, with the words "The Town of Oromocto NB INC AD 1956" in circular form between the inner and outer circles and the town Coat of Arms in the centre of the inner circle.
2. An impression of Corporate Seal of the Town is affixed to this By-Law.
3. The Corporate Seal of the Town of Oromocto shall be, and remain in the custody of the Town Clerk and shall be affixed to every agreement, contract, deed or other document to which the Town a party and which, in order to bind the corporation, requires to be authenticated by a seal.
4. The Town Clerk shall affix the Corporate Seal to any document referred to in Paragraph 3, which shall also be signed by the Mayor and Town Clerk and without such authentication; no such document shall have any force or effect.
