

BY-LAW 230

A BY-LAW TO ESTABLISH A PLANNING ADVISORY COMMITTEE

BE IT ENACTED by the Mayor and the Councillors of the Town of Oromocto as follows:

The Council of the Town of Oromocto under the authority vested in it by subsection (1) of section 12 of the Community Planning Act enacts as follows:

TITLE

1. This By-Law must be cited as the Town of Oromocto Planning Advisory Committee by-Law.

ADVISORY COMMITTEE ESTABLISHED

2. A planning advisory committee, considering of nine (9) members, is established.

EFFECTIVE DATE OF BY-LAW

3. This By-Law does not become effective until it has been filed in the registry office.

BY-LAW REPEALED

4. By-Law No. 141 "A By-Law to Establish a Planning Advisory Committee" is hereby repealed.
