

BY-LAW NO. 250

A BY-LAW TO CLOSE CERTAIN PUBLIC STREETS IN THE TOWN OF OROMOCTO

WHEREAS by virtue of Section 187 of the Municipalities act, the Town of Oromocto is empowered to stop up and close any or any portion of any, public street in the Town of Oromocto.

BE IT ENACTED by the Mayor and the Councillors of the Town of Oromocto as follows:

1. The streets as described below will be closed until such time as the Mayor and Council deem it necessary to reopen the Streets in question:

HIBERNIA CRESCENT, being more particularly described as beginning on Waasis road and extending 0.290 kilometers until it intersects with Evans Drive.

ENNISKILLEN DRIVE, being more particularly described as beginning on Hibernia Crescent and extending 0.341 kilometers until it again intersects with Hibernia Crescent.

ARMSTRONG COURT, being more particularly described as beginning on Enniskillen Drive and extending 0.208 kilometers until it again intersects with Enniskillen Drive.

A BY-LAW TO AMEND A BY-LAW TO CLOSE CERTAIN PUBLIC STREETS IN THE TOWN OF OROMOCTO

BE IT ENACTED by the Mayor and the Councillors of the Town of Oromocto as follows:

The Town Council of the Town of Oromocto, under the authority vested in it by Section 74 (1) of the Communities Planning act and Section 187 (3) of the Municipalities Act, enacts as follows:

By-Law 250, "A By-Law to close Certain Public Streets in the Town of Oromocto:", dealing with the closure of Enniskillen Drive, Hibernia Crescent and Armstrong Court, under the authority of Section 187 (2) of the Municipalities Act, is hereby changed by amending Section 1 to reopen Hibernia Crescent to intersect with the Waasis Road and Evans Drive as depicted in schedule "A" attached.
