## 7.b Oromocto Healthcare Committee

The Mayor advised a special presentation was made to the committee and some members of Council on the 17 March 2025 by Dr. Hanif Chator, an emergency doctor who works at the Waterville Hospital. He advised that many in New Brunswick have an alternative to waiting at hospital outpatients for low code medical issues by using the eVisit program where they can have access to a doctor virtually. The Deputy Mayor said they were looking for opportunities to promote the program and asking for municipalities to assist with that effort. A sub committee of the Oromocto Health Care Committee has been established to assist with the promotion.

#### 7.c Oromocto and Area Chamber of Commerce

Councillor Dawe reported the Chamber met on 12 March 2025. During the meeting the following items were discussed: two new board members were introduced - Deborah George and Emily Arseneault; the Business Awards Dinner which is scheduled for 1 May 2025; social media posts sharing, to create a greater visibility of the Chamber's activities; and the annual high-school \$1,000 scholarship award (deadline is 31 May 2025 to apply).
