# TOWN OF OROMOCTO BY-LAW 530 A BY-LAW TO ESTABLISH A PLANNING ADVISORY COMMITTEE

The Council of the Town of Oromocto under the authority vested in it by subsection Section 12 of the *Community Planning Act*, *R.S.N.B.* 1973 c. C-12, enacts as follows:

#### **PURPOSE AND INTENT**

1. To provide clarity and direction on the establishment, operation and terms of the members to ensure a proper balance of history, continuity and active engagement occurs.

### **TITLE**

1. This By-Law must be cited as the Town of Oromocto Planning Advisory Committee by-Law.

#### **ADVISORY COMMITTEE ESTABLISHED**

- 1. The Council of the Town of Oromocto hereby establishes a committee to be known as the Planning Advisory Committee which shall advise the Council on matters of planning.
- 2. The committee shall be composed of nine (9) members.
- 3. No more than two (2) members appointed to the Planning Advisory Committee may be members of the Council.
- 4. There shall be at least one (1) member who is a direct representative of the Base Commander of the Base Gagetown.

## **TERM**

- 1. Terms of appointment for members serving on the Planning Advisory Committee shall be in accordance with the requirements of the *Community Planning Act.*
- 2. No member may serve more than four (4) consecutive terms.

## CONSTITUTION

- 1. The Planning Advisory Committee shall adopt a constitution and may from time to time amend the Constitution so long as the provisions therein do not conflict with the *Community Planning Act*, the *Municipalities Act* or the By-Laws of the Town of Oromocto.
- 2. The Constitution shall be reviewed by the Planning Advisory Committee at least once every four (4) calendar years.

#### **BY-LAW REPEALED**

 By-Law No. 230 "A By-Law to Establish a Planning Advisory Committee" and amendments thereto is hereby repealed.
